Estimado señor Secretario:

Conforme a la Sección VIII. Trámite Posterior al Viaje o Misión Oficial, del Reglamento de Gastos de Viajes de la Cámara de Representantes (Orden Administrativa 2017-13), someto ante su consideración el informe sobre las gestiones oficiales realizadas en dicho viaje y un informe detallado de los gastos incurridos:
